SECOND WITNESS STATEMENT OF GARETH BONE

- I, Gareth Bone, of 180 Great Portland Street, London W1W 5QZ, say as follows:
 - This is my second statement in support of the Claimants' applications for relief
 against the Defendants. In this statement I confirm certain matters around initial
 notice of these proceedings, and provide a brief update on trespass incidents that
 have occurred over the very recent days.

 I attach a bundle of true copy documents to which I shall refer marked as exhibit "GB02". Numbers in square brackets refer to the page number of exhibit GB02. I adopt definitions from my previous statement.

Notice of the claim and hearing

- 3. I understand from the Claimants' solicitors that the claim form, brief details of claim, application notice, certificate of urgency and draft order were filed with the court in the course of the afternoon of 1 July 2025.
- 4. That evening, copies of all these documents were posted on Quintain's website at this address: <u>Trespass Injunction Quintain Ltd</u>. A screen shot of that page as it currently stands is at [2-3].
- 5. Also during the course of the afternoon of 1 July 2025, notices informing third parties of the fact that the Claimants were pursuing these proceedings were placed around the buildings affected by this claim on the areas marked with a coloured shield on the plan at [4]. A copy of the notice is at [5] and a document prepared by my team to demonstrate that notices have been affixed on the developments is attached at [6-24].
- 6. In the course of 2nd July 2025 the sealed claim form and application notice were added to the website, along with my signed statement and exhibit and the statement of Sarah Birchley with its exhibit. The exhibits to my statement were added to the website on 3rd July 2025.
- 7. In the afternoon of 8th July 2025 the notice at **[25]** informing of the anticipated hearing date was attached the main front door of each of the developments and also uploaded to the website.
